Re: Dožínky® Food Vendor Registration

Dear Vendor,

The New Prague Chamber of Commerce is closely monitoring Minnesota's response to COVID-19 but things look promising! That being said, we will plan to host our Dožínky® and Classic Car Cruise event as we normally do on September 17<sup>th</sup> and 18<sup>th</sup>, 2021. We will keep you all in the loop as we continue to receive new information and recommendations from state and national leaders.

It is also important to note that our Main Street/HWY 19 is in the middle of some extensive reconstruction that may impact the organization of our event. Our hope is that the bulk of the project is complete and will not affect our event however, the number of participants allowed in the Classic Car Cruise and Parade of Farm Pride may be decreased due to necessary detour routes. We will continue to keep you posted on construction progress as well.

As you may know, the Classic Car Cruise showcases many vintage show-worthy automobiles. They cruise down historic Main Street and the evening is capped off with a street dance. Saturday is Dožínky®, featuring the Parade of Farm Pride at Noon and followed by a leisurely afternoon of arts and crafts, ethnic food and music, historic displays and demonstrations. Under normal circumstances, we anticipate more than 15,000 festival-goers over the entire weekend. Please know that this number may be down due to any remaining restrictions which means we may have to also decrease the number of vendors. You will be contacted as we receive your application/payment.

If all goes planned, we hope you'll consider joining us in making our event a success again in 2021! We've enclosed Vendor Guidelines which include our pricing and rules and regulations. **As a reminder, you will need to file for a temporary food permit with either the State of Minnesota (Scott County side) or Le Sueur County Health Department (Le Sueur County side).** Please also see the enclosed MN electrical guidelines. We must receive your application with payment by July 30, 2021. Should the event be cancelled, you will be contacted regarding a reimbursement.

**You must supply your own electricity and water.** The vendor committee will approve and assign booth spaces on a first come first serve basis. **We are allowing no more than 2 of the following food types – Gyros, cheese curds, and corn dogs.** If you have a request for a certain booth space, you must let us know IMMEDIATELY. We will do our best to honor everyone's needs. **\*\*We are limiting each vendor to one spot\*\*\***

### Classic Car Cruise and Dožinky®: SEPTEMBER 17 and 18, 2020 FOOD AND BEVERAGE VENDOR GUIDELINES

- Cruise Night vendors may begin setting up **NO EARLIER** than 3 p.m. and must close by 1 a.m. Main Street closes at 5:30 p.m.; Cruise begins at 6:30 p.m. Please do not obstruct traffic when setting up your booth. Dožinky® food booths must be open for service by 10:00 a.m. and may remain open until 7:00 p.m. All food booths must be torn down and off Main Street by 9:00 PM on Saturday, September 19.
- The Dožinky® Committee will assign booth space and give approval of food items in the order in which complete applications, including payment, are received. If you have a request for a certain booth space, you must let us know IMMEDIATELY. We will do our best to honor everyone's needs. *We have limited space for trailers.* Final details will be sent in August. Booths are primarily placed on city sidewalks. The sidewalk area is 10 feet in depth (from building to the street). You must describe your booth/unit **in detail** on the application. All booths must be self-standing – no stakes.
- Food booths are required to have either MDH/MDA, or a temporary food license. Temporary food stand licenses will be granted through the State (Scott County or North side of Main Street) or Le Sueur County (Le Sueur County or South side of Main Street). The State charges \$90 (MDH license is good for both sides of hwy) and Le Sueur County charges \$50. We will work with each temporary food stand to make sure they get the best fit for their business.
- If your group has liability insurance, please furnish us with a certificate of insurance. If you do not, we want you to be aware that the **Chamber's insurance does not cover your booth.**
- Your group will be responsible for full clean-up of your booth area. We have experienced some problems in the past with booths leaving an area unclean after use. Please remember that each business along Main Street is gracious in the use of their space, and you will be responsible for leaving the area clean. **You cannot use business dumpsters to dump your garbage!**
- **You must supply your own electricity and water.** Generators used for electricity must be enclosed, or far enough away as to not disturb others. The New Prague Chamber of Commerce reserves the right to ask you to move your unit, or shut down your booth.
- **The New Prague Chamber of Commerce reserves the right to limit the number of vendors selling the same type of food.**
- If you do not follow the rules, you may not be allowed back in future years.
- The event is held rain or shine and NO REFUNDS will be given for no shows on this weekend.
- No refunds or cancellations will be given after August 1, 2021. If the event is cancelled due to COVID-19, vendors will be contacted.
- Please read all information carefully, and fill out the registration form (attached). **All forms must be filled in completely.**
